GUEST SPEAKER *PETER RAE HUNTER TO HAWKESBURY*

Peter opened the meeting with a Slide Presentation on his joint effort with Kincumber Rotary Club to present to the locals and tourists the History of Ship Building on Brisbane Water from the late 1800's to the early 1950's. Over this period 1700 ships were built along the eastern seaboard of Australia with 500 being built and commissioned on Brisbane Water using the current foreshore timber available. (The size of the tree cut down determined the size of the keel of the boat to be built). His slide presentation included models and a diorama display along the 4 Villages Walk at Kincumber Foreshore Brisbane Water. Peter also made mention of his idea for an Interpretive Walk from West Gosford to Patonga as there is a lot of History that should be recorded along the Point Clare-Brisbane Water Waterfront to the Peninsular.
