

Several have since suggested that our local members, both State and Federal, should be invited to be actively involved in our community projects in the years ahead. I plan to show the presentation to Deborah at some stage soon and also to float the idea with Chris Holstein, our local state member. The Association plans to invite Chris to speak at one of our meetings in 2012.

MURPHY'S BAY MARINA

An enthusiastic and concerned group of residents, 26 in number, responded to an invitation by Mr Bob Tuckwell, one of the Directors of Gemsted P/L to a question and answer session at the Boathouse Restaurant on Wednesday morning, 12th October. The restaurant dining room was kindly opened for the meeting by the proprietor.

As we indicated in our last newsletter, the size of the proposed marina has been of major community concern, together with the associated needs of parking at what would become a joint-use facility. Bob pointed out that the development is in no way connected with the restaurant which is leased from Gemsted as a separate entity.

GOODAYWANG UPDATE

As was foretold in our last newsletter, in conjunction with Gosford City Council, contractors have been busy in recent weeks fencing and planting out the northern bank at the reserve.

Even if you are unable to join us at our working bees on the first Friday morning of every month, you should go along and have a look at the amazing transformation that is taking place there. The lantana on the water side of the road has been cut and poisoned and the heaps will be left to rot down over time. New seedlings have also been planted in this area to restore the bush habitat.

We plan to continue our Bush Care activities with weeding and strengthening the stakes and plastic covers as we are able. We hope to be joined by the Pt Clare school's Environment Club again this term for more plantings.

NEWS IN BRIEF

- No word yet from Council on the naming of the reserve at Fagan's Bay as Bungaree Reserve.
- Aldi has rejected our request for a pedestrian link to the Pt Clare pharmacy.
- Brisbane Water jetty rents have varied slightly.
- No reconstruction has yet started on the narrow Glenrock Pde corner at Koolewong. The Mayor has again been contacted by letter.
- The broken footpath pictured in our last newsletter has been repaired. A full reconstruction of the whole path is planned by Council.
- Couche Park foreshore is still at the mercy of the tides; reconstruction has yet to start.
- Other associations have approached us suggesting a concerted effort to tackle train noise.

HALL REFURBISHMENT

Some of our members have recently joined the Hall Committee from whom we hire the Community Hall for our meetings. Elizabeth Ambler and Joel Brown, from Council, recently outlined the plans for the kitchen and toilet upgrades and from what we were told, the improvements will be much appreciated by all users.

Work may take place late in January if not before, so that regular users of the hall will not be inconvenienced.

Elizabeth also mentioned that if anyone has good ideas to make our Hall more user friendly, they should get in touch with her, come along to hall meetings and be prepared to lobby our local members for support through their community budgets.
